- Eligibility: Open to current USJF, USJA and USA Judo members. Membership cards **MUST** be presented at registration.

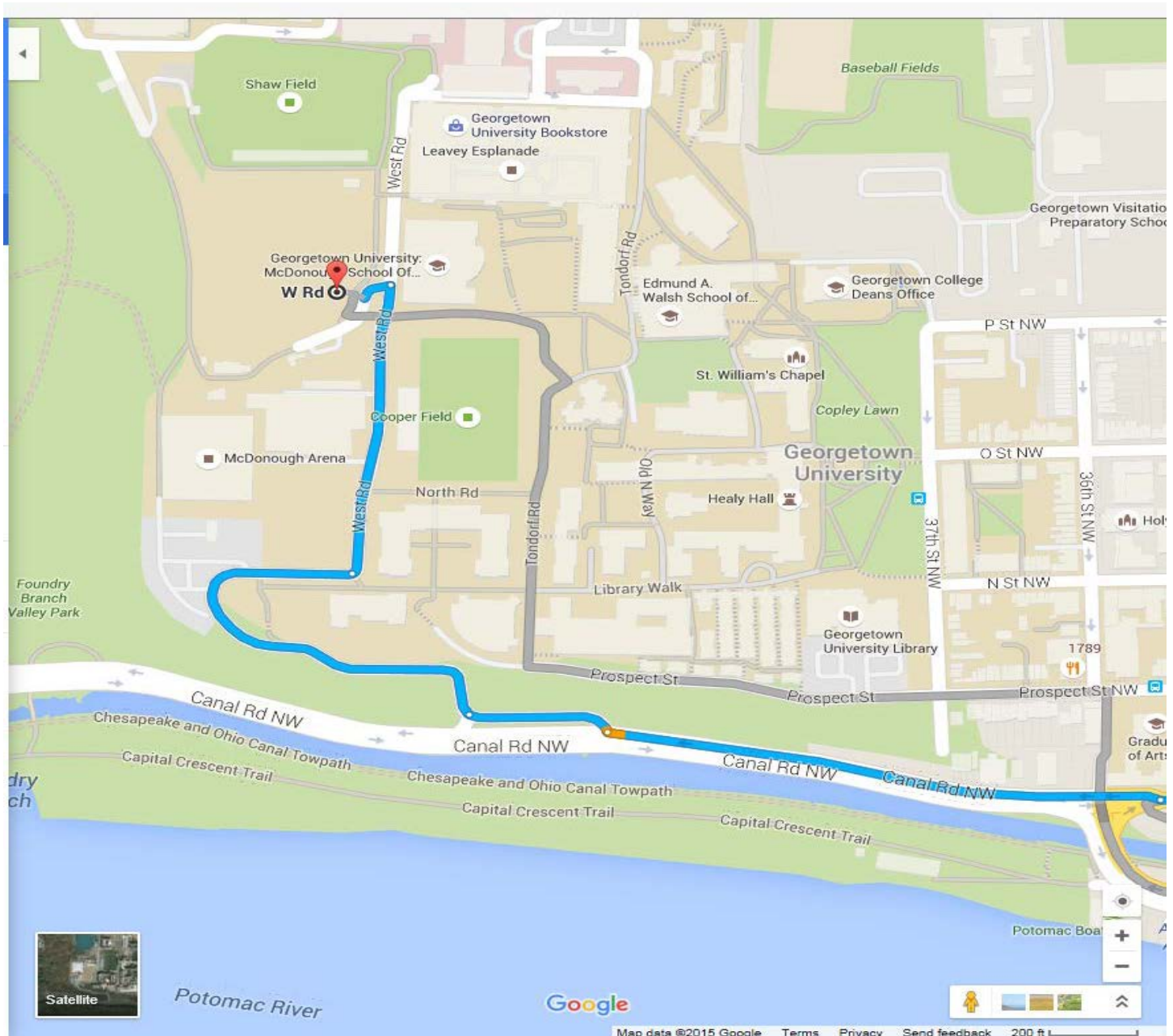
Topics to be covered:
