If you are certifying as a USA Judo Coach for the first time please check in early and begin registering before 8:30 am. Bring a passport size photo for your USA Judo Coach ID badge or email your photo to burris7276@cox.net. For those re-registering or wish to be considered for a USA Judo Coach level upgrade must fill out a USA Judo Coaching Certification New/Renewal form. The Clinic Entry fee does not include fees for USA Judo Coach certification. Checks or money orders for USA Judo certification fees listed on page 2 are to be made out to "USA Judo."

All Coach Certifications are renewable Online at USA Judo on an annual basis under Coaches. The 2019 membership period is January 1, 2019 – December 31, 2019. After January 1<sup>st</sup> there is a 90-day grace period for coaches to renew for insurance purposes. USA Judo now has a four year certification.

There are 7 Levels of Coach Certifications:

- Club Coach (Club Coaches will receive a State Level Certificate)
- State Level
- Regional Level
- National Level
- Continental Level
- International Level
- International Gold Level

The Club Coach Level is for head instructors who conduct classes in their respective dojos and wish to obtain a USA Judo Club Certificate. We are now allowing Senior Brown Belts to apply for State Level Coaching Certification. As for all Coach Certifications, the rank must be certified thru USA Judo; the individual must be at least 18 years of age and pass the required background screening.

All Coaches coaching at the National Level must have a minimum of National Level Certification.

All Coaches coaching at the International Level must have a minimum of Continental Level Certification.

- USA Judo background screening is available online on the USA Judo website.
- 2019-2020 Certification Fees; \$70.00 (includes ID card)
- Four year certification 2019-2022 (includes ID card)
- Subtract \$20.00 if you do not need an ID card. An ID card is required for coaching mat side.

Renewals: We are allowing coaches who were previously certified to renew their certifications, at the same level, without retaking the certification course. In order to progress up the coaching levels, coaches are required to take the appropriate course.

ID Cards: Your ID card is your credential to get onto the floor at USA Judo competitions. Additionally, many local tournament directors are allowing USA Judo Coaches with an ID card free access to their venues. We have also implemented a change in coach registration for events. If you have a USA Judo ID card, you will not need to pre-register for coaching at USA Judo events.

In consideration of being permitted to participate in any way, including travel to and from, in any tournament, practice, and related events and activities of the **United States Judo, Inc., United States Judo Federation, Inc., United States Judo Association, Inc., American Traditional Judo Association, American Jujutsu Federation, Virginia Judo Inc., Yamasakai Academy, and Sport Judo**, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
