Participation Eligibility: USJF, USJA and USA Judo members. Membership cards must be presented on the day of the event to participate on the mat. Be prepared to follow USJF, CDC, State and/or County guidance for COVID conditions. See USJF COVID protocol.

About the clinicians: Karen Whilden and Diane Tamai Jackson started to work as a kata team shortly after Karen moved to the east coast in 2000. They traveled the USA and the world competing in kata. Together, they are USA Senior Nationals female team champions in multiple years in Nage no Kata, Katame no kata, Ju no Kata, Kime no Kata and/or Kodokan Goshin Jutsu, including being awarded Best All-around female team. They represented the USA and took first place for several years at the PJC in Nage no Kata, Katame no kata and/or Ju no kata. They medaled at the World Masters Open Championships in multiple years in Nage no Kata, Katame no Kata, and Goshin jutsu. They medaled at the Fukuda International Kata Invitation in multiple katas, including Itsutsu no kata. In 2005, they were the USJF kata team of the year. In 2008, they took first place at the Cuban Olympics in Nage no Kata. They represented the USA at the 2007 Kodokan Invitational in Katame no Katame and at the first IJF World Judo Kata Championship in Ju no Kata in 2009. Both Karen and Diane served as the Shufu Kata Committee chair. They are both Pan American Confederation (PJC)-level kata judges in all five IJF-competed katas. Separately and together, they coordinated and taught many clinics in multiple katas to support judokas to expand their judo knowledge through the katas.

Karen Whilden, Rokudan, assistant instructor at DC Judo Club. Karen sensei started judo in 1970 while in college at the University of Idaho. In addition to being a judge in all five IJF-competed katas, she is a national-level judge in Koshiki no Kata. Even before moving to the east coast, Karen was a multi-time national champion in Nage no Kata, Katame no Kata, and Ju no Kata with various team members. She also represented the USA in the second PJU Championships (various katas, 2001, 2002, and 2004) with other team members.

Diane Tamai Jackson, Rokudan, assistant instructor at Hui-o Judo club. Diane sensei started judo around 1976 at Hui-o Judo. In additional to being a judge in all five IJF-competed katas, she is a national-level referee and national-level judge in Koshiki no Kata. In additional to teaming with Karen, Diane was a USA Team member at multiple IJF World Kata Championships (2013–19,

Nage or Ju) and PJU Championships (2013–19, Nage, Katame and/or Ju) with other team members.
