- (b) All Referee(s) (IJF A/IJF B/N4/N3) requesting 'elective' International events, must have officiated at (one of these events) Youth Nationals, Junior Olympics, and/or US Open, each calendar year.
- (c) Referee Commission Chair, Mr. Robert Fukuda, has taken a Leave of Absence. Mr. Calvin Terada and Mrs. Janet Johnson are 'interim co-chairs' of the commission.
