Eligibility to compete: A current **USJI, USJF or USJA membership card** must be presented at registration along with the **signed liability waiver** and **entry fee**. There will be no refunds of the entry fee. New and Renewal applications will be taken on site.

Contest Rules: Current IJF contest rules will govern EXCEPT no chokes or arm locks for 12 years old and younger. No arm locks for ages 13 to 16 years old. Any judoka under the age of 17 who wishes to compete in the Senior division will compete with no exceptions to the IJF rules. Any attempt to perform any technique with the intent to injure the opponent as determined by the officials on the mat will be an automatic hansokumake (disqualification). Any judoka competing fighting up in rank, age, or weight division will be subject to the rules of that division. All female competitors are required to wear a white t-shirt.

Elimination System: Modified Double Elimination

Awards: Medals will be given for first, second and third place in each division. Outstanding Junior, Outstanding Senior, Junior Team, and Senior Team trophies will also be awarded.
